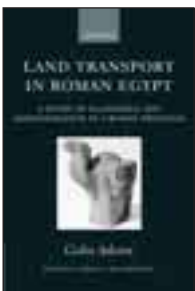

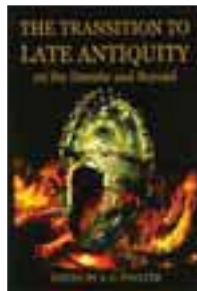

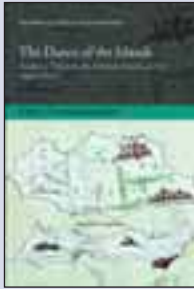

Simon Hornblower

Simon Hornblower is Grote Professor of Ancient History, and also professor of Classics, at UCL. Until 1997, he was university lecturer at Oxford and taught at Oriel and Jesus colleges. He began his career with a prize fellowship at All Souls, where he wrote a doctoral thesis which became *Mausolus* (Clarendon Press, 1982). Vol. III of his Thucydides commentary completes a much-interrupted project begun 22 years ago (vols. I, 1991, II, 1996). The interruptions included the third edition of the *Oxford Classical Dictionary* (1996), of which he is now co-editing the fourth edition with Tony Spawforth and Esther Eidinow. He was elected a Fellow of the British Academy in 2004.



A Commentary on Thucydides: Volume III: Books 5.25–8.109

This is the third and final volume of a commentary on the history of the first 20 years of the Peloponnesian War written by the great fifth-century BC Greek historian Thucydides. 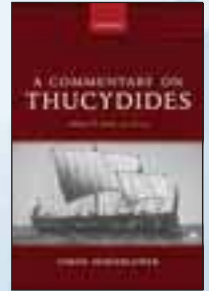
