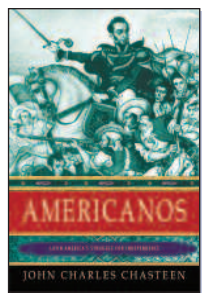

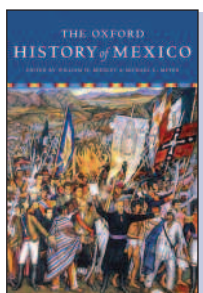

The Oxford History of Mexico is a narrative history of the events, institutions and characters that have shaped Mexican history from the reign of the Aztecs to the twentieth century.

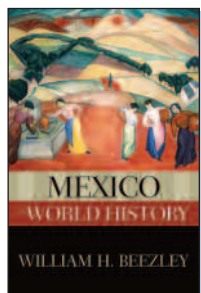

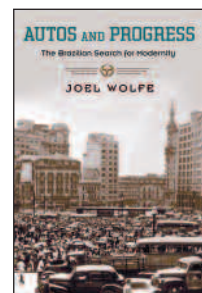
