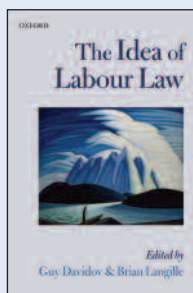


## The Idea of Labour Law

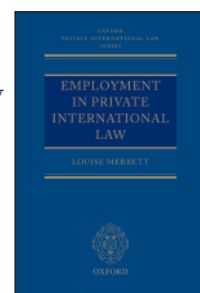
