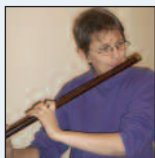


**BIOGRAPHY**

**Anne Smith**

For almost forty years now, 16th-century music—particularly on renaissance flutes—has been one of Anne Smith's central interests. She uses the insights gained from her research to inform her performances of music of this period, thereby bridging the gap between theory and practice. The Schola Cantorum Basiliensis where she teaches renaissance flute, solmisation, and 16th-century performance practice, provides an ideal environment for live research on historical performance practice.

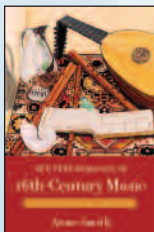

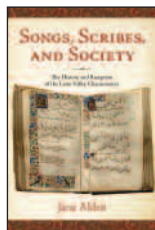


**Songs, Scribes, and Society**
