Maureen O'Hara

Maureen O'Hara is the Robert W. Purcell Professor of Finance at the Johnson Graduate School of Management, Cornell University. She holds degrees from the University of Illinois and Northwestern University. Professor O'Hara's research focuses on issues in market microstructure and she publishes widely on a broad range of topics including banking and financial intermediaries, law and finance, and experimental economics. Professor O'Hara is on the Board of Directors of Investment Technology Group, Inc. (ITG), an agency brokerage firm, where she serves as Lead Director and Chair of the Compensation Committee, and on the board of NewStar Financial, a commercial finance company.

David Easley

David Easley is the Henry Scarborough Professor of Social Science and a Professor of Economics at Cornell University. Professor Easley's research is in the fields of economics, finance and decision theory. In economics, he has published numerous papers on rational expectations, learning and wealth dynamics. In finance, his work with Maureen O'Hara focuses on market microstructure and asset pricing. In decision theory, he works on modelling decision making in complex environments. He is a Fellow of the Econometric Society and is an Associate Editor for the *Journal of Economic Theory* and for *Theoretical Economics*.

Microstructure as a Theory of Finance

Market microstructure has emerged as both an important research area in finance and as a major competitive issue in the design of securities markets. This book, written by two pre-eminent researchers in the area, argues that microstructure research also provides important insight into more general issues in finance such as asset pricing and corporate finance. Drawing on a decade of work, the authors show how the presence of asymmetric information influences not only the transactions costs of asset but also the return investors require to hold the asset. Consequently, the role of markets and their microstructure play a crucial role in influencing finance decisions for investors and firms alike.
